NOTICE TO SHAREHOLDERS

Sub.: Transfer of Equity Shares of the Company to Investor Education and Protection Fund (IEPF) Suspense Account.

Notice is hereby given that pursuant to the provisions of Section 124(6) of the Companies Act, 2013 read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016 ("the Rules") notified by the Ministry of Corporate Affairs effective from September 7, 2016 and subsequently amended vide notification dated February 28, 2017 ("the Amended Rules") [collectively referred to as "the Rules"].

The Rules, amongst other matters, contain provisions for transfer of all Shares in respect of which dividend has not been paid or claimed by the Shareholders for seven (7) consecutive years or more to DEMAT Account constituted under the said Rules.

It is noticed from the records that certain Shareholders of the Company have not encashed their dividends for previous years & for the year 2010-11 and the same remained unclaimed for seven consecutive years (i.e. none of the dividends declared since 2010-11, has been claimed by the Shareholders).

Adhering to the various requirements set out in the Rules, the Company has communicated individually to the concerned Shareholders whose shares are liable to be transferred to DEMAT Account under the said Rules for taking appropriate action(s).

The Company has uploaded full details of such Shareholders viz. Name and DP ID - Client ID / Folio No. and shares due for transfer to DEMAT Account on its website www.bluechiptexindustrieslimited.com. Shareholders are requested to refer to the web-link <http://www.bluechiptexindustrieslimited.com/static/about/dividend.aspx> and verify the details of the shares liable to be transferred to DEMAT Account.

Shareholders may note that both the unclaimed dividend and the shares transferred to IEPF Authority / DEMAT Account including all benefits accruing on such shares, if any, can be claimed back by them from IEPF Authority after following the procedure prescribed in the Rules.

In case the Company does not receive any communication from the concerned shareholders by 10th September 2018 or such other date as may be extended by the Authority, the Company shall, with a view to comply with the requirements set out in the Rules, transfer the shares to the DEMAT Account by the due date as per procedure stipulated in the Rules.

Please note that no claim shall lie against the Company in respect of unpaid dividend amount and equity shares after being transferred to IEPF.
